

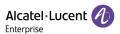
### **Integration Overview:**

The ALE interface in Protel I/O allows Protel and third party PMSs to communicate to the AHL of an OmniPCX Enterprise via TCP as well as to the OHL of an OLD (Office Link Driver) instance via TCP to access an OXO Connect. It covers the full portfolio of functionality that is available on a communication to Alcatel-Lucent Enterprise PBXs.
