

Partner Boost Opportunity Challenge (PartnerBoost21)

Terms & Conditions

The Partner Boost Opportunity Event (PartnerBoost21) is open to partners who have received an invitation to participate.

PartnerBoost21 will begin and end as described in the minimum requirements & conditions document, however, ALE INTERNATIONAL reserves the right to reduce or extend the duration of the program, by sending prior notice to the PARTNER, and without any liability to the PARTNER.

The PARTNER's managing director, or delegate authorised by the managing director shall:

- Accept the program's Terms and Conditions on behalf of the company
- Clearly designate the names of the persons authorised to participate (eligible participants)

Eligible participants within the PARTNER organisation will be ranked upon achievement as described in the minimum requirements & conditions document. Only the top ranked participants, having achieved the minimum requirement as described in the promotion details, will be rewarded.

To be considered/taken into account an Opportunity should be registered in the ALE Salesforce (MyPortal) system as PartnerBoost21. The Opportunity should explicitly identify the PARTNER name and contact person involved.

It will be at the sole discretion of ALE INTERNATIONAL whether the eligibility requirements have been met. The decision will be final and binding.

At the end of the PartnerBoost21 period, the list of invitees (winners) will be shared with the managing director or delegate authorised by the managing director.

Furthermore, all invitees of the event should be vaccinated. If they are not vaccinated (personal decision or other), that person will have to provide a negative test before joining (test not older than 48 hours).
